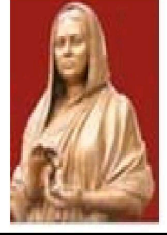



B. Kshirsagar - Dpb Dayanand College Of Education, Solapur** on the following conditions.

- 1) You have to apply for Eligibility Clearance with your Migration Certificate (if applicable), Transfer Certificate and PG Mark sheets to Eligibility section of PAH Solapur University through your Research Centre and complete your Eligibility process within two months from the issue of this letter. If you are not Eligible then your admission will be cancelled at any stage.
- 2) You have to pay the Prescribed fees as per University rules made time to time.
- 3) You have to appear and pass Ph.D. course work examination any time after one year of the date of registration and before submission of Ph.D. thesis (as applicable).
- 4) You have to submit six monthly progress report to the research centre through research guide and research centre by the end of July and January, every year. Failed to submit three consecutive progress report along with tuition fees, your Ph.D. registration shall stand cancelled automatically and you will not be informed by the University office.
- 5) The student should ensure that the Ph.D. Research Centre where he/she is allotted to carry out research work is duly recognized by PAH Solapur University.
- 6) The reserved category candidate who desires to avail the scholarship/free-ship benefits as per Govt. of Maharashtra and Govt. of India provisions/rules should apply to the concerned office through Scholarship Section/Ph.D. Research centre. The application sent directly to University Ph.D. Section will not be entertained.
- 7) All rules of research ethics and conduct of quality research work needed to be followed sincerely. If you are found guilty of completing the above conditions, your registration to Ph.D. program shall stand cancelled.

Back side Instruction on fees Structure

1. The Ph.D. admission fees for all students as per University fees structure per year chart is attached(Chart is also available on University Website) Student must pay the total fees at the time of admission .
2. Fees reimbursement is applicable only to SC/ST students through application made via maha DBT portal (as per income guideline)
3. SC/ST students, who will not apply (for any reason) in maha DBT portal are not exempted from paying the total fees.
4. If you are an employed candidate you will have to submit the sponsorship/NOC letter from your present employer.
5. Students entitled for JRF/SRF also must pay the total fees at the time of admission.
6. Fees concession is not applicable to any other category Ph.D. students as per mahadbtt portal.
7. No employed student or teacher is allowed to claim fee concession/reimbursement from The Government scholarship facilities.
8. Dues will be applicable (as per fees deciding authority) of fees not paid in time (yearly fees and other report submission fees).
9. Changes in Fees structure (as per statutory fees deciding authority) will be applicable to all admitted students of PET-8.

N.B.: The research students have to pay/deposit the fees at the concerned research centre. Students attached to University campus Schools/Departments should pay/deposit fees at the Finance& Account section PAH Solapur University and obtain the receipts.

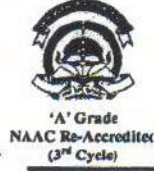
